By a vote of 38 to 0, the new bylaws passed. This reflects a lot of work by a wide group of people, resulting in a more defined document. After passage of the bylaws, the most pressing issue for board members at the recent December

meeting was the upcoming election of officers to be held at the 2012 Annual Meeting in March.

Under the new bylaws, limited terms create openings for new directors, hopefully bringing renewed energy and ideas to the table. They also provide for stability of the board by staggering terms, keeping two-thirds of the board intact for each election period. Of the seven elected board member positions,

three of the positions are up for election in March at our annual meeting: President (3 yr), Vice-President (2 yr) and one Director at Large (3 yr). These positons are held until the annual meeting by Paul Chouinard, Gerard La-Mothe and Alice Hafner respectively, who have given long and dedicated service to the organization.

If you would consider becoming a candidate. please think of this newsletter as an invitation to identify yourself. The board has adopted a manual, entitled *Best Practice Materials for Nonprofit Boards*, to help us in our reorganization tasks. It provides a wealth of information and guidelines for organizations like ours, including a clear description of what is expected of a board member. This information is available on our website under the Choate-Sias menu, along with the newly adopted bylaws. If the web is not available to you, please drop in during our open hours; I will gladly go over the information and expectations with you.

There is also an opportunity for board membership in one of the three non-elected positions on the board. At present there are three standing committees: the Old North Church, Greenbank's Hollow Historic Park and the North Danville Historical Room, located at the North Danville School. Each standing committee designates one mem-

ber to represent them as a voting member on the Society board. The North Danville Historical Room seat is vacant at this point, because no active committee currently exists.

It is an understandable situation, a result of the relocation of the headquarters of the Society to the Choate-Sias

House on Hill Street; for ten years prior, the Society was located at the North Danville School. When the archives were moved to Danville, it left in question the purpose and future of the historical room. The space was nicely filled by the Victorian Exhibit, led by the efforts of Vice President, Gerard LaMothe, and volunteers who built and decorated it.

Now is a perfect time for members interested in North Danville history to come forward. We would like to begin a conversation on how the room may best be utilized, reflecting both the mission of the Society and the wishes of the community. We have a successful model for identifying, organizing and implementing the goals of such a committee and would love to share it with interested members.

The nominating committee will begin meeting mid-January. By mid-February, the chosen slate of new Board members will be presented in our second newsletter of 2012. Time flies!

The proposed by-laws have been officially adopted by the membership. The plastering project and window restoration project at the Old North Church are nearly completed.
